Note: The Bachelor's degree in Agricultural Engineering shall not be insisted for those who have taken up make up courses of at least 12 credits in the semester system or 18 credits in trimester system for PG courses in Agricultural Engineering from Kerala Agricultural University.

- ii) Master's Degree in the relevant subject recognized by the Kerala Agricultural University with a minimum 55% marks in the traditional system or their equivalent. Only the qualifying marks without including any grace mark is permissible. The Provisions contained in Sec 3.4(I), 3.5 and 3.6 of the UGC Regulations 2018 shall apply.
- iii) Net conducted by ASRB/ ICAR/ UGC/ AICTE or similar test accredited by the UGC or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 and 2016 and their amendments from time to time as the case may be exempted from NET/ SLET/ SET:

Provided, the candidate registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ Bye-laws/ Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/ SLET/ SET for recruitment and appointment of Assistant Professors or equivalent positions in Universities/ Colleges/ Institutions subject to the fulfillment of the following conditions:

- a. The Ph.D. degree of the candidate has been awarded in a regular mode;
- b. The Ph.D. thesis has been evaluated by at least two external examiners;
- c. An open Ph.D. viva voce of the candidate has been conducted;
- d. The candidate has published two research papers from his/her Ph.D. work, out of which atleast one is in a refereed journal;
- e. The candidate has presented at least two papers based on his/her Ph.D. work in conferences/ Seminars sponsored/ funded/ supported by the UGC/ ICSSR/ CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Director/Dean (Academic Affairs) of the University concerned.

Note: NET/ SLET/ SET shall also not be required for such Masters Programmes in disciplines for which NET/ SLET/ SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/ SET.

PG candidates in the relevant discipline will be considered in the absence/shortage of NET/Ph.D holders.

Terms & Conditions

- i. The candidate must be a citizen of Indian and shall not be over 50 years as on 01.01.2025.
- ii. Reservation benefit will be allowed as per the norms of Kerala Public Service Commission on production of Community Certificate (in the case of SC/ST), 'Non-Creamy Layer certificate' (in the case of OBC), Disability certificate (in the case of differently abled) issued by the competent authority.
- iii. The appointment will be on contract basis and purely provisional for a period of one year or till the appointment of regular hands in the post, whichever is earlier.
