Assembly And 2D Drawing Functionality, Specialized Tools For Sheet Metal, Weldments, Surfacing. Molds, Product Configuration, Manufacturability Check, Sophisticated Components And Part Libraries, Structural And Motion Analysis Capabilities, Electrical Cable And Pipe Routing Functionality, Advanced Surface Flattening, Sustainable Design(LCA), Advanced Photorealistic And CAM Etc.

#### Conditions for participating in Tender

- 1. The tender form can be downloaded from the following website link in the internet http/www.kau.edu/tenders. The cost of tender form is Rs. 1000 + GST @ 18% (Rs. 1,180/-). The same should be submitted by way of DD in favour of the Dean, KCAET, Tavanur payable at SBI, Kuttippuram and should be included along with the tender. EMD @ 1% of the quoted amount (minimum of Rs. 1,500/-) should be submitted by way of separate DD drawn in favour of the Dean of Faculty, KCAET, payable at SBI, Kuttippuram along with the tender document. A pre-bid agreement in kerala stamp paper worth Rs. 200/- should also be enclosed.(Form of agreement can be downloaded from the website http/www.kau.edu/tenders under the related document section).
- 2. Rate quoted should be inclusive of all charges such as installation charges and Government duties, if any.
- Valid EMD exemption certificate from the Store Purchase Department, Govt. of Kerala or Udyog Aadhar Registration certificate should be submitted, if the firm claims EMD Exemption.
- 4. The software should be installed at the expenses of the successful bidder.
- 5. The sealed cover containing the tender document should be superscribed as "Tender for the supply of Solidworks CAD Software for various research activities under AICRP on FIM Scheme as per B1-8405/23 " and send to the Dean of Faculty, KCAET, Tavanur Pin 679 573, Malappuram District, Kerala State.
- 6. Tenders received late or incomplete in any respect will be summarily rejected, without any notice and the decision of the undersigned on such matter will be final.

- Successful bidders will have to execute an agreement in Kerala stamp paper worth Rs.200/and remit security deposit @5% of the value of the articles ordered less the amount of EMD,
  drawn as DD/fixed Deposit/bank guarantee.
- 8. Service: The firms /companies/ bidder should ensure on-site service support for the software.
  - The maximum period required for delivery and installation of the software should be mentioned.
  - If any license or permit is required, Bidders must specify the same in their tender and also state the authority to whom application is to be made.
- 9. <u>Payment</u>: Details required for e-payment (Details of bank account) shall be furnished along with the tender.
  - Payments will be made only after satisfactory supply and installation of the software.
- 10. Warranty: Minimum one year warranty updation should be ensured. Extended warranty/updation preferable.
  - If the Supplier, having been notified, fails to rectify the defect(s) within one to two
    weeks' time, the warranty will be extended by the period for which the software lying
    idle without repair.
- 11. Bids not satisfying the above conditions will be rejected.
- 12. The Dean of Faculty (Agrl. Engg.), KCAET, Tavanur, shall have no obligation to convey any reason for rejection of any bid. It shall be open for The Dean of Faculty (Agrl. Engg.), KCAET, Tavanur to reject even the lowest bidder in the interest of the University and no reason need be given thereof.
- 13. Withdrawal from the tender after having accepted or failure to supply within the specified time or according to specifications will entail cancellation of the order and attract legal procedures as per the agreement.
- 14. All subsequent Government orders connected to tenders and any revision in the rates of taxes would also be applicable to this tender.
- 15. In addition to these all other General Conditions annexed in the Store Purchase Manual of Government of Kerala are also applicable to this tender.
- 16. Details of warranty, after sales service offered on expiry of normal warranty period available should be mentioned.
